The Ayala High School Band and Color Guard will again be hosting the Western Band Association 3<sup>rd</sup> Annual **Music in Motion** Field Tournament on Saturday, October 17, 2009. This exciting event being held at Ayala High School will bring together the top High School Marching Bands from around the state of California to compete. This event will draw close to 5,000 spectators including participants, instructors, family, friends, and Booster Clubs.

## **BECOMING AN EXHIBITOR AT THIS EVENT**

If you are interested in becoming an exhibitor or vendor at this event, the information contained in the attached page will outline the requirements and costs to participate. We are offering exhibitor and vendor space outdoors in blocks of *ten foot by ten foot increments*. You may order more than one space as required for an additional fee.

The prices are included on the General Vendor Space Rental Application Form. The price of each rental space includes only the space (10'x10'). Any other equipment will be the responsibility of the exhibitor. Vendors may include music, arts, crafts and other merchandise.

## **ADDITIONAL INFORMATION**

- Smoking, illegal use of alcohol or drugs, firearms, and illegal gambling devices are not permitted within the campus at any time.
- Vendors will need to set up/tear down with minimal noise before/after competition hours. Please keep areas neat and leave your area clean at tear down.
- Adhere to all quiet zones
- May not solicit sales outside of the approved booth space. Vendors can sell only from their rented booth space. We do not allow walking in the stands or around the grounds selling merchandise or handing out fliers. No access to the field or other school grounds will be allowed.
- Exhibitors will need to provide their own EZ up, tables, chairs, location lighting, extension cords or other necessary equipment. Ayala will provide electricity, however, if your needs exceed normal power supplies the use of whisper quiet generators will be required. Please contact us for more information.
- **Written cancellation must be received by 4:00pm on Friday October 9, 2009.**
- All Fees must be paid at time of application. This event is held Rain or Shine.

This application **DOES NOT** guarantee an exhibitor space. All booth spaces are subject to Ayala BAC approval and acceptance. All applicants agree to the terms and conditions set-forth by the Ayala BAC and the school policies.
